CREDIT AGREEMENT (TERMS & CONDITIONS)

In consideration of Horner Millwork Corp. (hereinafter "Horner") extending credit to the business entity applicant named herein, the business entity applicant (hereinafter "customer") agrees to the following terms and provisions: The customer unconditionally guarantees the timely payment to Horner for all goods and materials sold and delivered and/or labor furnished by Horner to the customer. All invoices tendered with respect to said goods and materials and/or labor shall be due and payable in full within thirty (30) days of the date reflected on said invoices. The customer shall pay a finance charge of 1-1/2% per month (18% per annum) on any invoice past due. The customer shall pay a \$20.00 service fee for all stop-payment checks and/or insufficient funds returned checks. The customer acknowledges and agrees that in the event customer's delinquent account is turned over by Horner for collection, the customer shall pay, as liquidated damages, an attorney's fee equal to twenty-five (25%) percent of the gross amount then due and owing, which fee the customer agrees is fair and reasonable. The customer agrees that any lawsuit commenced by the customer against Horner shall be brought in Bristol County, MA. The credit terms and provisions specified herein shall govern all present and future transactions between Horner and the customer until such time as Horner may otherwise agree in writing. The individual whose signature appears below on behalf of the customer represents herein to Horner that said individual is a duly appointed agent of said customer with the authority to bind the principal herein. The customer certifies herein that the information contained in the customer's application for credit is complete and accurate, and authorizes Horner to conduct such credit investigations from time to time as Horner deems necessary and advisable.
